# **WIHV Report Guide:**

WIHV CQI - Developmental Screening & Follow Up Report

This guide provides technical information and additional program instructions for users accessing the WIHV CQI – Developmental Screening & Follow Up Report.

## Report purpose:


The WIHV CQI – Developmental Screening & Follow Up Report was designed to provide sites with monthly data on developmental screenings and follow up for children enrolled in their program services.

#### Who is counted:

Actively enrolled children who meet the denominator criteria for each measure counted in this report.

## Report Functionality:

Each measure of the report has a stacked bar showing the count of children depending on whether they meet the criteria for the measure. Selecting a segment of the bar (green if they meet the measure's numerator criteria, gray if they meet the measure's denominator but not numerator criteria) will populate the table on each page of the report with a list of those children by Child DAISEY ID, Child Name, and other relevant data (pictured below).

## Report Measures – Measure 3

## Measure 3 Denominator:

Children aged 6 months or older on the last day of the reporting month who do are not already receiving services for an identified delay.

<u>Note</u>: Please review the child clients that are included in the denominator but not in the numerator. These are the clients that will appear in the client list when you click on the gray bar. If any of those clients were not screened because they were already receiving services for an identified delay, remove them from the denominator.

*Measure 3 Numerator:* Of those, children who received an ASQ-3 within the last 6 months of the last day of the reporting month

## Report Measures – Measures 5, 6, 7

#### Denominator Status:

The denominator for measures 5, 6, & 7 is the same: children whose most recent ASQ-3 (as of the last day of the reporting month) indicated scores below cutoff and/ or parent concern.

**Measure 5 Numerator:** Of the children counted in the denominator, those whose screen was shared with primary care provider.

**Measure 6 Numerator:** Of the children counted in the denominator, those who were referred to Early Intervention or another provider for further evaluation.

**Measure 7 Numerator:** Of the children counted in the denominator, those whose caregiver declined a referral.

## Report Measures – Partial SMART Aim Measure

### SMART Aim Measure Denominator:

Children whose most recent ASQ-3 was a concerning screen which occurred more than 60 days before the last day of the reporting month.

**Partial SMART Aim Measure:** Of those, children who received an evaluation by Early Intervention or another community provider within 45 days of the screen. To determine the numerator status, you will need to look up clients meeting this partial numerator status to determine if they received targeted, home visitor-delivered promotion by the next home visit.
